Sunanda Pravin Gambhirchand College of Nursing, under Seva Mandal Education Society: a Trust registered with the office of the Charity Commissioner, Mumbai, Maharashtra having its register office at 338, R.A. Kidwai Road, Matunga (E), Mumbai- 19, affiliated to the Maharashtra University of Health Sciences, Nashik.

AND

Dr. Bhanuben Mahendra Nanavati College of Home Science (BMN) affiliated to the Shreemati Nathibai Damodar Thackersey Women's University, Mumbai, for provision of health services under the Nurse Led Clinic. The aforesaid colleges are hereafter known individually as 'Institute' & collectively as 'Institutions'.

➤ **Aim of MOU:**

To develop and strengthen the students personalities of both the institutions, in order to preserve the 'wealth of health', of the people of all the age groups and take effective measures for it, at all the three levels of prevention i.e. primary, secondary and tertiary.

➤ **Objectives of MOU:**

- to provide and enhance freedom of expression and sharing of knowledge, skills and experiences amongst peer students and teaching faculties of both the institutions.
- to facilitate maximum and the fullest utilization of resources such as the expert skills of teaching faculty and students, for the provision of first aid and basic health services for students and staff of entire campus
- to inculcate and enhance a passionate service attitude among the students of the institute.
- to create opportunities for development of their competitive skills with special emphasis on Nursing skills.
- to facilitate access to basic health facilities and preventive health attitude amongst teachers and students of both the institutions.

➤ **About Sharing and Utilization of facilities:**

- SMES's Smt. Sunanda Pravin Gambhirchand College of Nursing and Dr Bhanuben Mahendra College will be jointly utilizing the housekeeping room on the 6th floor of Dwing of Dr. Bhanuben Mahendra Nanavati College of Home Science (BMN) with the purpose of running the NURSE LED CLINIC wherein the College of Nursing will facilitate the following:

Providing basic and emergency health care services to the entire campus.

- Attending to the sick person in a comfortable environment
- Allowing the sick person space for resting
- Observing the sick person post first-aid.

➤ **Proposed Modes of Collaboration:**

Seva Mandal Education Society's Smt. Sunanda Pravin Gambhirchand College of Nursing, 338, R.A. Kidwai Road, Matunga (E), Mumbai- 400 019 And Dr. BMN College of Home Science, Mumbai, proposes to collaborate through the following:

- Propagation of health education in the areas of mutual interest through periodical meetings and/or communication.
- Co-operation, mutual support and conduction of various health activities with consent of faculty members.
- Any other appropriate mode of interaction agreed by and between both the college / departments of the Seva Mandal Education Society.

A well-planned schedule of activities and its conduction will be drafted with the consent of the coordinators of both the institutions and with the valuable advice and consent of the higher authority of Seva Mandal Education Society.

➤ **Duration of the Programme & MOU:**

- The undersigned MOU will be valid for twenty- five years from the date.

Terms & Conditions:

- The cost of infrastructural utility including use of room shall be borne by both the colleges/ departments individually.
- Both the institutions shall take the responsibility of the maintenance of the room whenever it is used.
- However, the colleges are free to arrange sponsors for part or whole of the Programme.
- The MOU may be amended, renewed and terminated mutually by both the colleges. In case of termination of the MOU before time, either college shall reserve the right to terminate this MOU, by giving a written notice of not less than 30 days to the other college.

➤ **Confidentiality:**

The colleges entering into the MOU shall agree to hold in confidence all information/data/ records obtained by either of them during the exposure in the Clinic and shall not disclose any of the material facts relating to the MOU to any third party. Violation of the confidentiality will hold the MOU to be Null and Void.

However, the data may be utilized for a higher purpose such as research.

➤ **Co-ordinators:**

- The responsibility for organizing and conduction of this Nurse Led Clinic shall be of the coordinators of both the Nursing college. However, in case of camp a harmonious coordination is expected from both the institutions.

Both the colleges can depute their faculty members for the health camps.

The undersigned agree to the terms of this Memorandum of Understanding.

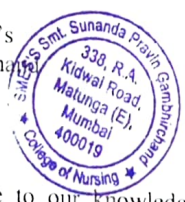
