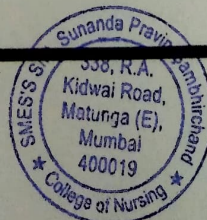

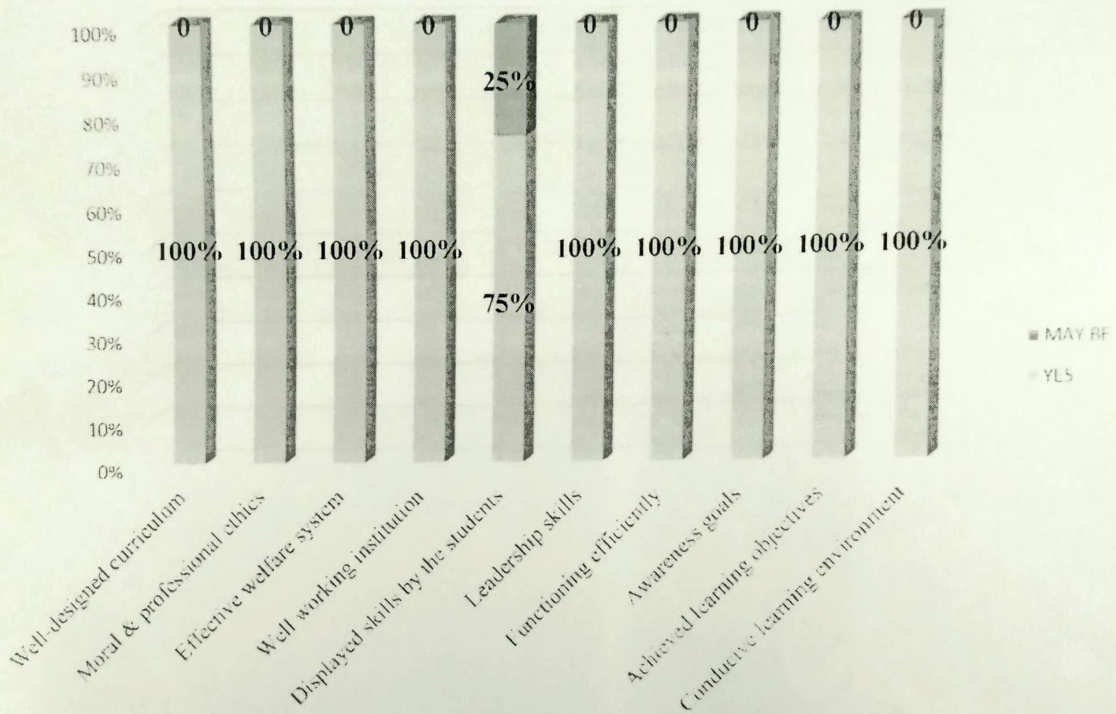

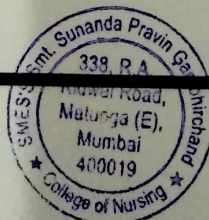
**REMARK-**

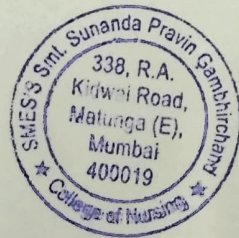


