- She further urged to have an add -on bridge course that can add importance in skill building
  of nurses as one of the current faced issues in the hospitals recruiting novice nurses is the
  dearth of practical skills due to the virtual training that took place during Covid Pandemic.
  IQAC took the suggestion on record.
- IQAC co-ordinator informed the group that a new initiative 'Alumni Led Clinical Teaching' has been started to update the students with recent knowledge and skills as per the expertise of the alumni. Dr. Mantri enquired if the students are provided certificates after they complete the workshop. He suggested to provide such certificates as they would add weightage to the cv and help in placement.
- Madam Belinda Sawant also mentioned about grooming the students with teaching empathy and communication along with the skill sets.
- On the future plans of the college, Sir Mantri explained the need for bigger vision. He suggested to think in the prospects of Cluster university as the sister concerned colleges in the campus belonged to different university. In his view, this would bring in lot of flexibility and independence in decision making and could help in better curriculum implementation with freedom of choice instead of bureaucracy.
