#### Attendance

- 80% in Theory Irrespective of the kind of absence to appear for University Exam.
- 100% in each of the Practical Areas before the award of degree.
- Students who do not fulfill the minimum requirement prescribed by the University will not be allowed to appear for the University Examination.
- 4) In case of absence a prior written permission by the student's guardian is mandatory. ( Note- The leave may be granted only on genuine ground at the direction of the Principal.
- Students have to be punctual and regular in attending classes theory, practical, clinical, Cocurricular as well as extra co-curricular activities.
- The regular college timing: 8.00 am to 4.00 pm. From Monday to Friday

8.00 am to 1.00 pm on Saturday

- 7) If students remain absent for more than one day the guardian have to meet the Class Teacher.
- 8) Absence during examination is not permitted. The exam shall not be repeated.
- The performance of mid-term and pre-final examination will be taken into consideration for the internal assessments marks.

#### General rules to be followed by the students.

- In case of absence, prior permission is necessary. It is mandatory for the students to submit the leave letter signed by parents in the format provided by the college.
- Absence from attending the classes / clinical posting will be considered only on the medical ground; medical certificate is essential with a written note of absence, by the students & her Guardians.
- Students have to follow all the rules, regulations and policies of the library and various laboratories.
- Internship includes 8 hours of integrated clinical duties in which 2 weeks of evening & night shift duties are included.
- 5. Internship should be carried out as 8 hours per day @ 48 hours per week.
- Students will be supervised by nursing teachers during internship.
- Fourth year final examination to be held only after completing internship.
- Total 8 unit tests will be conducted for each subject, as soon as the unit's syllabus is taught in the
  college and learnt by the students, in addition to mid-term and pre-final examination.
- The students must read the notice boards regularly in order to know the important information.
- The students have to submit their study assignments within the stipulated time to the concerned teachers.
- 11. The students have to fulfill all the requirements as per the norms of the syllabus.
- The final examination will be held by the Maharashtra university of Health Sciences every year (Summer & Winter)

Uniform – Prescribed uniform will be provided by the college to be worn for the clinical experience in the Hospital / Community & during the educational visits. The students will be charged for the same.

#### Extra curricular Activities

Student council and Student Nurses Association: The student council will be formed through democratic system of election. Thus students will be given opportunities to develop their leadership qualities, and their

#### Research

The students thirst for curiosity will be quenched by encouraging students to conduct the research projects and forming a journal club. The students will be encouraged to conduct and present their researches at collegiate, university & interuniversity level. The students will be availed maximum opportunities to express their talents and virtues, and will be appreciated and rewarded.

#### Conduct & Discipline.

- Students will be under the control of the Principal throughout the training.
- The rules & regulations to be strictly followed as laid down by the authority.
- Disciplinary action will be taken by the Principal if rules are violated.
- Students should maintain ethical & professional behavior both in and outside the college, in hospita & community premises.
- No jewellery should be worn in the clinical area.
- Using cell phones to the classroom & clinical area is strictly forbidden.
- Maharashtra University of Health Sciences, (MUHS) Nashik shall take the decision regarding granting of the term & the eligibility of selected candidates. The decision taken by MUHS will be final & the candidate will be bound by it.
- Parents & local guardians should meet the Principal and/or Class Teacher whenever called for.
- Classroom should be always kept clean and neat. The garbage must be thrown in the dustbin.

#### Hostel

- Students will be day scholars.
- Very limited hostel facility is available on payment only to outsiders.
- · We have a Memorandum of Understanding with Runwal Group for the hostel facility at "Thane" (Ghodbandar Road)

#### Books

Books will be provided by the college against required payment. Students need to buy a set of text book of the concerned subjects per year. Reference books, Journals & Newspapers can be referred through the college library. Internet facility is available in the library.

Teaching Learning Activities: The teachers will use the innovative and varied teaching - learning activities' suitable for a group as a whole as well as an individual student. The students need to take interest and initiative in learning as it is a joint venture of student and teacher towards quest for the TRUTH. #### Fee

Fees are subject to change. On being admitted to the course the student shall be required to pay full tuition fees as per the rules / norms prescribed by the Pravesh Niyantran Samiti and Fees Regulating Authority of the State Government.

All the fees are to be paid by digital mode or Demand Draft or online pay mode (RTGS / NEFT) to be drawn in favour of "Seva Mandal Education Society's College of Nursing" between 10.00 am to 2.00 pm. on week

days. In case the student is paying the fees late she shall be entitled for a penalty. In case due to any reason the student has cancelled the admission it is mandatory to them to pay a full fees for that academic year. In case the student is paying the fees later than stipulated date then she shall pay a penalty as per the institution's rule.

#### Refund of fees:

The Ministry of Human Resource Development and University Grants Commission have considered the issue and decided that the institutions and Universities, in the Public Interest, shall maintain a waiting list of students/candidates. In the event of a student/ candidate withdrawing before the starting of the course, the waitlisted candidates should be given admission against the vacant seat. The entire fee collected from the student, after a deduction of the processing fee of not more than Rs.1,000/-(one thousand rupees) shall be refunded and returned by the Institution/ University to the Students/Candidates withdrawing from the programme. Should a student leave after joining the course and if the seat consequently falling vacant has been filled by another candidate by the last date of admission.

The institution must return the fee collected with proportionate deductions of monthly fee and proportionate hostel rent, where applicable. The Candidate, who applies for cancellation of admission, shall be entitled for refund of fees as per Seva Mandal Education Society's management rules as stated by the The Ministry of Human Resource Development, which has been stated above.

## Essentials for refund of fees

- a. The student should submit written application on the plain paper for cancellation of admission (with the date) along with fee receipt.
- The purpose of cancellation should be clearly stated in the application.
- The application should be signed by the Head of Department.
- d. The application should be inwarded by the department's office.

Anti-ragging Cell - The College abides by the MUHS University regulations and implements. It's antiragging resolution under Maharashtra Prohibition of Ragging Act (1999) section – I of section 1. Ragging of any students is strictly prohibited and strict disciplinary action to the extent of dismissal from the college will be taken if any student is found to be indulging in any of the ragging action (directly or indirectly). have a special cell for dealing with any act of ragging, anti national or unlawful activities being attempted by any student. Students have to fill up the anti-ragging Affidavit at the time of admission.

## As per Clause -3, UGC Regulation 2009

Ragging is an act of abuse by spoken or written words. Teasing or treating rudely a fresher to cause psychological harm, public insult, raise fear or threat or disruption or physical injury, forcing to entertain or financial extortion; a student asking to perform lewd acts; exploitation of services, outrage of modesty or sexual assault; creating annoyance or apprehension or intimidation; showing power of authority or superiority to derive sadistic thrill or perverted pleasure by senior students or any conduct that affects the mental health and self' confidence of a fresher or any other student.
